Kevin J. Mahoney, Ph.D. is a faculty member at the Boston College Graduate School of Social Work where he serves as Professor as well as Director of the National Resource Center for Participant-Directed Services (NRCPDS). This new national center offers training, technical assistance, research and policy support to states and other organizations that want to offer, or are already offering, participant-directed care services.



During his 30 year career in gerontology and long-term care, Dr. Mahoney has served in a number of policy making and administrative positions in the state governments of Connecticut and California. Dr. Mahoney has developed and implemented innovative partnerships between private insurance and Medicaid to finance long-term care. He has served as the National Program Director for the Cash & Counseling Demonstration and Evaluation, a policy-driven evaluation of one of the most unfettered forms of consumer direction of personal assistance services, funded by the Robert Wood Johnson Foundation and the Office of the Assistant Secretary for Planning and Evaluation at the U.S. Department of Health and Human Services. An expert on state government and long-term care innovation, he speaks and writes extensively on consumer direction, the roles of the public and private sectors in financing long-term care, long-term care insurance and care management.
